How long does a Canadian Solar warranty last?

The warranty effective date shall be defined as the date of installation or ninety (90) days after the delivery by Canadian Solar, whichever date is earlier. For Canadian Solar inverter products, the warranty can be extended up to 20 years at the Buyer's option prior to the applicable warranty effective date.

Do Canadian Solar inverters have a warranty?
