What are Mexico's energy reforms?

Mexico has announced a proposed series of reforms to its energy sector (the "Reform"). This proposed Reform includes eight new laws and three amendments to existing laws, significantly reshaping the country's energy sector.

How did Mexico reform the energy sector in 2024?

In November 2024, Mexico approved a constitutional reform aimed at modernizing the energy sector by conferring on the Mexican state the responsibility for the transition to renewable energy sources. This reform was part of a broader effort to reinforce state control over key sectors and ensure energy sovereignty.

What changes are taking place in Mexico's energy sector?

In Mexico, after 6 years of the current ideology, several changes on the Energy sector are taking place. These changes are impacting the definition and mechanisms where private companies can participate within both the Power (including Generation and Supply) and Oil (Exploration and Exploitation) industries.

Does Mexico have an independent energy regulator?

Mexico will no longer have an independent energy regulator, as the Energy Regulatory Commission (CRE) will be absorbed by the Ministry of Energy. Key legislative changes in the Reform include: Transfer of CRE's Regulatory Powers: The powers of the CRE will be transferred to the newly established National Energy Commission (CNE).
